**2020 DOG LICENSES:** All dogs 7 months or older are to be licensed each year. Neutered/Spayed dog fee is \$12.00 and Non-Neutered/Non-Spayed dog fee is \$15.00. A late fee of \$10.00 PER DOG goes into effect May 1, 2020 for all residents who have not renewed their dog's license for the current year.

## Official Notice: To Residents and Businesses of Millstone Township

Recycling is mandated by the State, County and Municipal Statutes.

Millstone Township must continue to recycle to meet aggressive recycling goals set by the State and County. As the Recycling Coordinator of the Township, my responsibility is to continue to strive to meet those goals by aggressively enforcing Township ordinances. Random inspections within the Township resulted in citations being issued for lack of compliance with Chapter 19, SOLID WASTE MANAGEMENT, of the Revised General Ordinances, Township of Millstone. Some brief passages from this section follow:

It shall be mandatory for all persons, who are owners, lessees, or occupants of residential property, to separate newspapers, glass bottles and jars, tin and bi-metal cans, plastic containers, aluminum cans, corrugated cardboard and electronics as hereafter defined from all other solid waste produced by such residence for collection and ultimate recycling of materials.

I urge you to continue to do your part in keeping Millstone Township clean and to show that we are an "Environmentally Concerned Community".

## VAPING BY YOUTH ON THE RISE

Although e-cigarettes have been around for more than a decade, vaping rates have skyrocketed in recent years, especially among teens. Monitoring the Future, an annual survey that measures drug and alcohol use of 8th, 10th, and 12th graders has found that teen vaping is on the rise, and E-cigarettes are the most common type of tobacco product used by U.S. middle and high school students. This survey showed the average past-year vaping for each grade: 8th grade 17.6%; 10th grade 32.3% and 12th grade 37.3%

And the users are getting younger and younger. According to a state report released on Oct. 31, 2019 by the New Jersey Hospital Association, in 2018 detection of e-cigarette use began around age 13. The 2019 data shows incidence beginning around age 11. It couldn't be clearer that vaping companies, many owned by existing "big tobacco" companies are targeting a new generation to get hooked on nicotine. It is more important than ever for parents and teens to be informed of the potential dangers that can result from vaping.



Vaping is the act of inhaling and exhaling the vapor produced by the heated nicotine liquid of an electronic cigarette, vape pen, or personal vaporizer. E-cigarettes come in many sleek designs and the vaping liquids can be made to taste like candy, fruit, ice cream, or any other food or beverage. Since

they leave little odor, e-cigarettes are particularly easy to hide and can be used discreetly in public places, including school. A recent presentation hosted by the Millstone Alliance showed how a hoodie, like those worn by hundreds of students in schools, could be used as a vaping device - through specially engineered, but discreet hoodie strings.

Unfortunately, many teens do not realize that vaping contains high levels of nicotine. When asked what students thought they were smoking, many believed that the liquid contained in the e-cigarette was just flavoring. But according to JUUL, a popular vape device among teens, the nicotine content of one JUULpod is equivalent to one pack of cigarettes.

Early nicotine addiction can harm brain development and alter nerve cell functioning. Nicotine can harm parts of the brain that control attention, learning, mood, and impulse control. It causes lung irritation akin to that seen in smokers and people with lung disease and has been found to damage vital immune system cells. In addition, defective e-cigarette batteries have caused fires and explosions which have resulted in serious injuries.

Why are teen's vaping? The most common reasons were because a friend or family member used them, the availability of fun flavors, and the belief that e-cigarettes are less harmful than other forms of tobacco. Teens reported e-cigarettes were easier to get than other tobacco products, cost less, and can be used where other tobacco products are not allowed. Some students even reported that they used e-cigarettes to try to quit using other tobacco products-a ploy many e-cigarette companies use to market their products.

With millions of teens hooked on the device, the challenge is how to treat nicotine addiction in children as young as 11 years old. Withdrawal symptoms may include anxiety, irritability, difficulty concentrating, and loss of appetite. Additionally, physicians who are treating teenagers for addiction are facing a series of dilemmas. For example, anti-smoking therapies such as nicotine patches and gum are not approved for children. In addition, kicking any addiction requires discipline, patience, and a willingness to follow a treatment plan-something that doesn't come easily to teens.
