You may also mail your fee along with proof of rabies and neutering/spaying to 470 Stage Coach Road, Millstone Twp., NJ 08510. Neutered/Spayed dog fee is \$12.00 and Non-Neutered/Non-Spayed dog fee is \$15.00. A late fee of \$10.00 PER DOG goes in effect May 1, 2019 for all residents who have not renewed their dog's license for the current year.

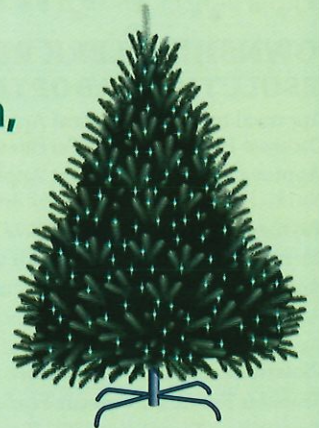

# RECYCLING

## Official Notice: To Residents and Businesses of Millstone Township

Recycling is mandated by the State, County and Municipal Statutes.

Millstone Township must continue to recycle to meet aggressive recycling goals set by the State and County. As the Recycling Coordinator of the Township, my responsibility is to continue to strive to meet those goals by aggressively enforcing Township ordinances. Random inspections within the Township resulted in citations being issued for lack of compliance with Chapter 19, SOLID WASTE MANAGEMENT, of the Revised General Ordinances, Township of Millstone. Some brief passages from this section follow:

It shall be mandatory for all persons, who are owners, lessees, or occupants of residential property, to separate newspapers, glass bottles and jars, tin and bi-metal cans, plastic containers, aluminum cans, corrugated cardboard and electronics as hereafter defined from all other solid waste produced by such residence for collection and ultimate recycling of materials.

**Solid waste:** Solid waste shall mean and include all garbage and rubbish normally produced by the occupants of commercial, industrial and residential property and disposed of by private or public pick-up.

**Proof of collection service:** Proof of collection service shall mean a written record, log, bill or document evidencing receipt of service for the collection of solid waste for the preceding month from a person lawfully engaging in private solid waste collection services within the Township.

**Violations and penalties:** Any person, firm or corporation who violates or neglects to comply with any provision of this section or any rule or regulation promulgated pursuant thereto, shall be liable to the penalty stated in Chapter I, Section 1-5. (Fines could be as much as \$2,000.00 for non-compliance)

**Note: Court appearance may be required for summons.**

I urge you to continue to do your part in keeping Millstone Township clean and to show that we are an "Environmentally Concerned Community".

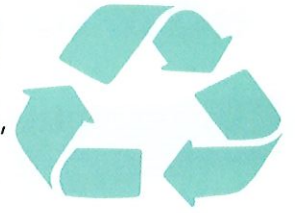

## Items that are accepted at the Recycling Center are:

Newspapers, magazines, cardboard boxes (MUST be flattened)

**RECYCLE** means to process old, used items in order that the material can be used to make new products. Examples of things that are often recycled are glass bottles and jars, plastic bottles, newspapers, aluminum cans and mixed papers.

**REDUCE** refers to lessening the amount of items or resources that are consumed, using only the amount that is needed, and looking for alternatives that will lessen our use.

**REUSE** means extending the 'life' or reusing an item rather than discarding or throwing it away.

## What is SINGLE STREAM RECYCLING?

Single Stream Recycling reduces collection costs, permitting use of single-compartment trucks and automated handling of fewer, larger containers. Reduced sorting encourages residents' participation and may generate more materials. However, increased processing costs reduce the value of the collected materials and, without clear guidelines for those generating the recyclables, may increase contamination by unsuitable and food contaminated products (more residual waste created during processing). Please review the list of permitted recyclables to enter the single stream process. Workers for Millstone's Recycling Yard are going to be more vigilant with turning away non-recyclable items.

### MANDATED RECYCLABLES



#### Bottles & Cans

**Aluminum Cans:** DO NOT INCLUDE FOIL, PIE TINS, TRAYS, COOKWARE

**Tin & Bi-Metal Cans Glass Bottles & Jars:**

DO NOT INCLUDE DISHWARE, LIGHT BULBS, CERAMICS, WINDOW GLASS, MIRRORS

**Plastic "Pourable Containers":** Neck of bottle smaller than body, #1 #2 ONLY **Remove Caps prior to recycling.**

Be careful to completely empty any container used for automotive fluids. Any leftover chemicals in containers can be disposed (call 732- 683-8686 for appointment) at the Household Hazardous Waste Facility.



#### Leaves and Grass Clippings

DO NOT DISPOSE WITH HOUSEHOLD TRASH. Grass clippings can be left on the lawn, added to compost piles, or brought to special drop-off at county landfill (for a fee).



#### Car Batteries & Motor Oil

Car batteries can be brought to a scrap yard. Motor Oil can be brought to Monmouth County Household Hazardous Waste Facility (call 732- 683-8686 for appointment) or local service stations. Most common household batteries (A, AA, AAA, C, D, 9 Volt) **can be disposed in regular trash.** However, rechargeable batteries should be brought to retail store drop offs (check www.rbrc for locations). Silver "button batteries" should be returned to municipal or county sponsored drop offs. Millstone Township's Municipal Building located at 470 Stage Coach Road has a receiving bin for "button batteries" only, NO OTHER BATTERY TYPES WILL BE ACCEPTED.



#### Newspapers

**Newspapers and any inserts that come with the paper.** DO NOT INCLUDE ANY NEWSPAPER USED FOR PET WASTE OR HOUSEHOLD PROJECTS



#### Corrugated Cardboard

**Waffle section between layers.** DO NOT INCLUDE FOOD CONTAMINATED CARDBOARD (e.g. pizza boxes) OR WAXED CARDBOARD. Flatten boxes.



#### Mixed Paper

**Includes: letterhead, colored and white paper, junk mail, soft cover books, chipboard (e.g. cereal boxes).** DO NOT INCLUDE FOOD WRAPPERS, PAPER CUPS OR PLATES OR ANY OTHER PRODUCT USED FOR FOOD OR PERSONAL HYGIENE. NO HARDCOVER BOOKS (UNLESS COVER & BINDER IS REMOVED)



#### Bulky Recyclables

**Tree Parts** (limbs, branches, trunks) can be brought to the Municipal Brush pile during drop-off events. See Millstonenj.gov for dates. NOTE: Stumps, roots, vines and leaves are not accepted on site.



#### Computers/Electronics Recycling Drop-Off

Free drop-off bin located at the Recycling Center during normal recycling center hours.

# HOW TO KNOW IF YOUR KID IS VAPING MARIJUANA AND WHAT TO DO ABOUT IT



One of the best resources for parents who want to stay on top of current drug trends and how to have important conversations with their children about their concerns and family rules regarding substance use is The Partnership for Drug-Free Kids ([www.drugfree.org](http://www.drugfree.org)). They are on top of the latest trends and

provide research based information and resources, as well as great advice for parents.

One of the trends they are following is E-cigarettes and Vaping. E-cigarettes, vaporize nicotine rather than burn tobacco. These have revitalized the tobacco industry by eliminating smoke and with it the carcinogens and lung irritants. E-cigarettes effectively deliver nicotine, which many people don't realize, and can cause or sustain nicotine addiction. E-cigarettes are safer than smoking tobacco but they are far from safe.

A recent article posted on their website highlighted how "vaping" is transforming the marijuana industry by delivering tetrahydrocannabinol (THC), the psychoactive chemical in marijuana, without smoke. Vape pens are the preferred mechanism for this type of marijuana use and vaping is the preferred term. "E-cigarette" is not used to describe this use, because it carries the negative associations with tobacco cigarettes while "vaping" carries no similar stigma. If you don't think that "Big Tobacco" is behind the push for marijuana legalization - guess again.

The word "vape" is new and chic and named "word of the year" by the Oxford Dictionary in 2014. If they were picking a word today, it would more likely be JUUL or Juuling, the wildly popular "stealth vape" of adolescents. Juuling kids are vaporizing flavored e-juices with nicotine, but what about vaping marijuana?

According to Monitoring the Future, an annual survey of nearly 50,000 adolescents, 3 percent, 8 percent and 10 percent of 8th, 10th, and 12th graders respectively had vaped marijuana in 2017.

According to a study published by the American Academy of Pediatrics, e-cigarettes use may lead to marijuana initiation. Their research shows that e-cigarette use may be a marker of risk-taking behaviors, and that e-cigarette users are more likely to smoke cigarettes and drink alcohol, which are associated with marijuana use.

There is also the concern that vaping nicotine, which is in Juuls and many other vaping devices, may pave the way to other substance use problems in the developing adolescent brain. Aggressive marketing in states where marijuana has been legalized may also contribute to increased curiosity about marijuana while at the same time reducing its perceived harm. Most teens today think that recreational marijuana is legal everywhere due to aggressive marketing and its presence on social media.

## FIRST THINGS FIRST – HOW IS MARIJUANA VAPED?

While many young "vapers" say they inhale flavored liquids like Gummy Bear, German Chocolate Cake and Cotton Candy, youth can vaporize marijuana - either the ground plant itself, waxes often referred to as dabs, or THC and CBD oils.

Selling equipment to vape marijuana in its leaf, dab or oil form is a booming business, with these items being available at any local vape shop already in many towns. One popular vaporizer, Pax 3, is described as the "I-Phone" of vaporizers, and includes a free Android or iOS app to control temperature, play free games, manage firmware and lock the device.

In California, a company called EAZE sells disposable all-in-one marijuana vape pens and cartridges. Flavors include Blueberry Kush, Lemon OG and Mango Passion Fruit. They market these as wellness products with advertising that reads, "Hello Marijuana, Goodbye Insomnia" or "Hello Marijuana, Goodbye Hangover."

The Juul can also be used to vape marijuana, but the device has to be hacked in order to use it with THC oils and, as with most things, there are YouTube videos demonstrating how. There are also companies making pods that fit a Juul, so a THC oil pod may be in the future.

## Marijuana is used recreationally and medicinally, so what's the big deal for adolescents and young adults?

According to the CDC, marijuana use may have long-lasting or permanent effects on the developing adolescent brain. Negative effects include:

- Difficulty with critical thinking skills like attention, problem solving and memory
- Impaired reaction time and coordination, especially as it relates to driving
- Decline in school performance
- Increased risk of mental health issues including depression or anxiety and in some cases, psychosis where there is a family history of it
- Research also shows that about one in six teens who repeatedly use marijuana can become addicted, as compared to one in nine adults

It's really important for parents and caregivers to note that these impacts of marijuana differ from the impacts on a fully mature adult brain. Delaying substance use of any kind, including marijuana, gives your child the best opportunity to have optimal brain functioning.

### How can I recognize use, especially if there is no smoke and telltale smell?

Vaping can be difficult to detect as there is no smoke, minimal odor (although you may catch a whiff) and the vapor produced dissipates rapidly. However, just like smoking, vaping marijuana can result in bloodshot eyes, dry mouth and thirst, increased appetite and shifts in behavior and mood. Sometimes, there is a noticeable change in friends and a decrease in activities that were once enjoyed.

You may also find vaping paraphernalia such as devices that look like flash drives, gel jars that contain dabs, and pods or cartridges that contain THC oil. There's a lot of high-tech-looking equipment that can accompany vaping, so if you're not sure, it might be time to talk to your child about what you found.



### What can I do if I suspect my child is at risk for vaping or is already vaping marijuana?

Given the growth of marijuana use and vaping among American youth, it's a good idea to explore your son's or daughter's views on vaping and perceptions of the risks.

1. **Have conversations often.** Before any talk, it helps to be able to share facts, but don't assume that an information download to your child will translate into healthy behaviors.
2. **Look for good opportunities to have a discussion.** You can do this when passing a vape shop, smelling marijuana on the street, seeing someone vaping on TV or in person or seeing one of the ads for vapes.
3. **Try to listen, rather than give a lecture.** Open-ended questions can be a great way to get your child's perspective, i.e. "I understand that some kids are vaping marijuana. What are your thoughts about it?" If you know they are already vaping marijuana, you might ask "What does vaping marijuana or THC oil do for you?" Perhaps it's a way to fit in, handle social anxiety or address boredom. Get to the root of "why."
4. **Set clear expectations.** Express your understanding of the risks, but also why a person may want to vape. Share why you don't want him/her vaping, and remember, it's important to avoid scare tactics. Be honest.
5. **Teach refusal skills.** It's likely that your teen or young adult will be introduced to vaping marijuana by a friend or older sibling. It helps to rehearse what he/she will say if that happens.
6. **Have your loved one talk to other trusted adults who can reinforce your message.** Sometimes, messages coming from your pediatrician, school counselor, favorite aunt or uncle, etc. can be more impactful.
7. **Model healthy behaviors.** If you come home from work and discuss what a tough day it's been while popping open a beer, pouring a glass of wine or smoking a joint, **you are conveying this is how you handle stress.** It's healthier for your child – and you – if you take a walk with the dog or a bath or go for a run rather than turn to substances as stress busters.

**The Millstone Alliance to Prevent Substance Abuse** has addressed this issue at a parent program held last spring. The Alliance also sponsored a student presentation at the middle school and maintains many resource materials that can help parents have "the talk" with their children.
