Ms. Scott opened and closed the meeting to the public at 7:35.

Monmouth County Municipal Open Space Grant #12-04 Baird Homestead:

Ms. Butch is preparing the close out letter to submit for reimbursement.

Monmouth County Municipal Open Space Grant #14-12 Millstone Park Phase I:

Ms. Butch is compiling a close out list for the grant. An Adhoc meeting should be scheduled shortly.

Monmouth County Municipal Open Space Grant #17-03 Cady Property:

Currently being processed for reimbursement.

Barnegat Bay Preserve: - Waiting for reimbursement of grant.

Park Guide: The council reviewed the preliminary map that was created. Deputy Mayor Grbelja would like to add the County and State Parks in a light shade and also add trails. A legend will also need to be created to show what activities are available. Mr. Madeam discussed trail maintenance.

Clambake Wrap-up: Ms. Scott thanked the council for their help and noted that the profit was \$1,200 more than last year. Deputy Mayor Grbelja stated it was a wonderful event.

Fall Newsletter: The deadline for all articles is August 19th. Suggestions for articles were horse industry, sports article pertaining to open space, deer management education, did you know, and mushroom farming. Members were asked for additional suggestions.

New Business:

Drone Update: Mr. Madeam discussed the unfortunate news of the lost drone. Mr. Madeam noted it should be a team effort at all times when piloting the drone. During the flight, the drone's low battery light went on and Mr. Madeam asked it to return back home. It seemed

to lose signal and it could not be located. Mr. Madeam stated that the aircraft and lens were lost, not the night vision camera. Deputy Mayor Grbelja asked if there could have been a defect in the battery. Mr. Madeam said he lost sight of the drone during the flight and then it went down. The council discussed ways to prevent this in the future. Mr. Madeam discussed a small device called a tile and uses blue-tooth for the GPS. The cost of the tile is about twenty-one dollars. The tile has a much longer range and the battery can be replaced if needed. Deputy Mayor Grbelja made a motion to replace the drone using fundraising funds and Ms. Scott seconded. The council unanimously voted to replace the drone.

Millstone Day: Members of the council were asked if anyone would like to volunteer during the day. The council will provide information for residents to view. Maps drone pictures, picture boards, and other material will be on display.
