Chapter V (Fees), Section 5-14 (Fees for Chapter XIV: Building and Housing), Subsection 5-14.3 State Uniform Construction Code Fees, Building and Housing is hereby amended as follows:

- 5-14.3a.–e. No change
- 5-14.3f Electrical Subcode Fee as per State. The electrical subcode permit fee shall be as described below:
  - 1-13 No change
  - 14. Trench(other than pools) shall be based on length of run:
    - (a) No change
    - (b) Greater than 500 and less than 1,000 fee: \$75 Plus \$75 per every additional 500 feet
- 5-14.3g. Fire Protection Subcode Fee. The fire protection subcode permit fee shall be as described below:
