NEW/OLD BUSINESS:

1. Summer Camp –

R/C Balkovic – Summer Camp staff wages need to be increased for the 2025 Camp season. Minimum wage has increased. We are going to have a Year One employee start at \$15.50 and it will increase by \$0.50 for each year completed, Year 2 will make \$16.00, Year 3 Will make \$16.50, going up to year eight where we will have a cap of \$19.00 per hour.

C/ Strickland – How are we on counselors?

R/C Balkovic – We are in a very good spot right now. Have a good amount of them coming back already and we did not even hit spring break yet, which historically is when I get them in. Also have a good number of new hires.

2. Flag Football –

C/Strickland – Season starts up on April 25th. We are partnering with New Egypt. I would also look to get pricing for some portable scoreboards.

R/C Balkovic – We would need at least three scoreboards as those are the number of games we have going on.

3. Soccer –

R/C Balkovic – Soccer is off and running. We have two teams in the Central Jersey Inter-Town Rec Soccer League and the first games took place on last Saturday (April 5th, 2025). We have a co-ed Boys team in the 3rd and 4th Grade Division and a Girls team in the 5th and 6th Grade Division. The Pre-K and Kindergarten and 1st and 2nd Grade Division also started on the same day.

4. Martial Arts –

R/C Balkovic – Martial Arts has been doing very well. Feels like the enrollment has been increasing every session.

5. Lacrosse –

C/ Curtis – They are playing nicely this year.

R/C Balkovic – I agree everything seems to be going well with them so far.

6. Cheer –

C/ Curtis – Cheer is going well. I know they are looking to do Sideline Cheer with AYF (American Youth Football).

7. Old/New Business

- a. R/C Balkovic: The Recreation Basketball Board has good feedback so far. Hopefully we can have continued success for when the season actually starts up.

R/C Balkovic – For Girls Basketball I am working on a plan with West Windsor PAL and Allentown Recreation to possibly play against each other. We were all struggling with low enrollment this year and believe we can make a more successful experience for all involved.
