At your request, we have reviewed the Mining Permit Renewal Application for the above referenced mining site and report as follows:

#### 1. Documents Submitted

- "Soil Erosion and Sediment Control Plan/Revised Mining Plan", A. Buck Mining & Materials, Inc., Lots 11 and 13.01, Block 28, consisting of five (5) sheets prepared by Sharif H. Alv. P.E. from AmerTech Engineering, Inc., dated July 19, 2010, last revised June 22, 2022.
- "Environmental Impact Statement" for Buck Mining & Materials, B. Inc., prepared by Sharif H. Aly, P.E. from AmerTech Engineering. Inc., dated July 14, 2004, last revised March 11, 2019.
- C. "Stormwater Management Report" for Buck Mining Pine Hill Materials, Inc., prepared by Sharif H. Aly, P.E. from AmerTech Engineering, Inc., dated July 20, 2010, last revised March 11, 2019.

#### 2. Project Location & Description

The subject property is known as Lots 11 and 13.01, Block 28, A. consisting of approximately 22.27 Acres. The site has frontage and access on Pine Hill Road.

- B. The property is located within the RU-P (Rural reservation Zone District). The application incorrectly shows that this project is in the R-170 Zone.
- C. The site has been used for mining operations since the 1960's. The estimated amount of soil that remains to be removed is over 500,000 cubic yards.
- D. Haul Routes: the trucks leaving the mining site are required to turn right onto Pinehill Road and travel west to Millstone Road. The route then continues south along Millstone Road to Sweetman's Lane to Route 33. Trucks coming to the mine are required to use the same route. Any revisions to the approved haul route will require Township Committee review and approval.

## 3. Site Plan Review Comments

- A. The Applicant should provide status of the agreement to sell this property to the County Park System.
- B. The Applicant has submitted a status report dated June 15, 2022 with the application (copy attached).
- C. The Applicant has posted two (2) letters of credit totaling \$138,840.00 where a Site Restoration Cost Estimate AKA Performance Guarantee calculated in July 2016, is \$228,000.00.
- D. The NJDEP inspected this site and issued a report on March 7, 2022 stating some deficiencies. The mine owner has made some improvements and responded on March 31, 2022.
- E. The Detention Sediment Basin has not been completed yet, but it has been functioning satisfactorily.
- F. The haul route, Pine Hill Road has been repaired by the owner.
- G. The Freehold Soil Conservation District has issued a Biannual Renewal Permit until December 30, 2022.
